## Demurrage and Storage – Tauranga Container Terminal / MetroPort / Mount Maunganui Wharves

Unless otherwise specified in the published tariffs, storage fees are charged on the basis of per tonne or cubic metre, whichever is the greater. All rates are as specified unless otherwise individually agreed. Free storage days are calculated on a 7-day week period. No cargo is to be delivered early without the prior approval of the Manager Operations or his authorised agent.

Re-Invoicing to an alternative party can be requested and will be generated for a minimum charge of \$65.00

**Please note:** Hazardous goods do not attract the standard demurrage free days. All hazardous goods must be managed in accordance with the ERMA legislation. All import storage and any export storage incurred due to early receipt will be invoiced directly to the shipper where possible.

### Begin Receive Date (BRD) – Export Storage Policy

Begin Receive Date (BRD) for cargo at TCT Will be calculated utilising the known ETA of the vessel at the point of time the cargo is gated in. The BRD will be updated in real time and fixed in relation to the confirmed vessel published ETA, advertised on Port Connect.

Export cargo can generally be delivered early to the terminal prior to the BRD. Any early receipt storage days, which are calculated from time of gate-in date up to the advertised BRD will be invoiced to the account of the shipper.

The 7-day free receipt period is fixed and comprises from the start of advertised BRD to the published ETA of vessel. Export containers that incur additional dwell (and power & monitoring) charges after the 7-day free receipt period due to vessel delay or cargo renominations will be invoiced to the account of the shipping line.
